MSM Performance:

Market behavior during the previous week (5-9 April) was calm. However, certain stocks attracted interest as a result of healthy first quarter financials, such as Al Maha Ceramics. There was a return from speculators to the market, as well as several special deals. The general sense in the market is still cautious, as investors await further clarifications, regarding results, macroeconomic announcements and any changes within the oil markets. Despite this, several companies are still highly attractive, especially in the Financial and Services sectors. We also noticed interest from investors on some small-cap companies.

We expect corporate announcements/disclosures, partial reinvestment of dividends, listing of bonus shares in the market and any news related to large projects in the country, to bring support to the market and give further confidence to investors. This will also present an opportunity to build positions in companies expected to benefit from the aforementioned.

The MSM30 ended the previous week unchanged on mixed shares performances closing at 6,269.25. In the previous week, the MSM Shariah Index ended the week up by 0.45% to 957.88 points.

During last week, Al Arabi Oman 20 Index increased by 0.15% to finish at 1,089.63 points as turnover amounted to RO 19.36mn. Al Arabi GCC 50 Index increased by 0.78% to close at 1,213.65 points. Also, "Al Arabi MENA200 Index" increase of 0.87% to close at 1,128.81 points.

The sub-indices analysis showed a drop in the Financial Index performance by 0.35% to 7738.49 mainly pressurized by Ahli Bank, HSBC Oman and Ominvest.

In the previous week, bonus shares with a nominal value of Ro 0.100/- amounting to OMR 49.7 million were listed on the exchange as follows

Such listings in addition to previous similar ones shall result in more depth and acceleration of market activities.

Al Anwar Holding Co. said in statement on the MSM website that the CMA has approved the company's proposal for buying back its shares up to 10% of total outstanding shares. The buying back process would be governed by the related regulations. The statement revealed that a Board meeting would be called to convene an Extra Ordinary General Meeting of shareholders for approving the Buy Back transaction.

The Service Index went up by 0.43% to 3,448.34 mainly due to Al Jazeera Services, Renaissance Services, Oredoo and Oman Inv. & Finance.

The Industrial Index increased by 0.32% to 8284.98 supported by Oman Cement, Al Jazeera Steel Product Co. and Oman Cable Industry Co.

Al Anwar Ceramic Tiles kick started the earnings release season, with 5.1% y-o-y decrease in its net profit at RO 2.1mn, in spite of 5.1% y-o-y increase in sales, due to higher expenses clocked in during the quarter (+10.7% y-o-y). Its net profit margin has declined from 31% in Q1'14 to 28% in O1'15 .

Al Maha ceramics reported it first quarter results indicating a 29% y-o-y increase in its net profit. The 8.4% y-o-y decline in revenue for Q1'15 was more than offset by the 17.6% y-o-y reduction in total expenses, resulting in net profit margin improvement of 7% (Q1'15 NPM at 25%) when compared with net profit margin of Q1'14 at 18%. The stock posted daily gain of 2.72% on the back of the announcement .

In terms of nationalities trading, it was noted that both local and foreign individuals were net buyers registering RO 2.33mn and absorbing pressures from local and foreign institution investments. Speculative activities were seen in the market .

Trading statistics revealed that both number and value of traded shares went down by 27.03% and 21.28% respectively to 103.8mn shares worth RO 21.9mn. Two special deals were done on Global Financial Investment Co. with total value of RO 1.24mn as pre the available data .

The Capital Market Authority (CMA) unveiled a new draft code of corporate governance and seeks listed companies, auditors, and consultants' opinions on it. According to media reports, adjustments such as mandatory change of auditors within three years (instead of four years now) and strengthening rules related to related party transactions were included in the new draft.

Locally, His Majesty Sultan Qaboos pointed out the significance of speeding up the preparation of plans capable of realising economic diversification, completing major projects of public benefit and attracting more investments. Moreover, activating areas of partnership with the private sector and encouraging the setting up of small and medium enterprises were also been pointed out by His Majesty. Such key topics will certainly be under focus of the all related parties.

In our weekly technical analysis, and as we mentioned in our last week report that MSM index will be approaching the first resistance level at 6,300 points, its actually what happened, where the index approached this level with a difference of 6 points, while the index didn't hold and closed below this level.

Regionally, the Kuwaiti National Assembly approved amendments to the Capital Market Authority's (CMA) law. A key amendment includes imposing penalties on those involved in bogus trades. On different note, Saudi Arabia posted its highest production levels in at least 12 years in March at 10.3mn barrels according to Bloomberg citing the Saudi oil minister. The Saudi Minister stated that the Kingdom will continue producing on same levels and OPEC (the Organization of Petroleum Exporting Countries) will not cut production without cooperation from non-OPEC producers. Dubai Financial Market led the gainers up by 3.86% followed by Qatar Exchange (+2.47%)


Globally the Royal Dutch Shell PLC agrees to buy BG Group PLC for \$70bn deal, the largest in the sector for 10 years according to media. The move aims to create a strong company in both oil and gas. On deal completion, it is expected that 25% will be added to Shell oil and gas reserves and 20% to production .

US Federal Reserve minutes for Mid-March meeting reveal a divergence in the first-rate hike in June as it suggests that Fed officials have not ruled out a June rate increase. The Fed chairwoman pointed out that it would be uncomfortable raising rates if inflation were to weaken further.


Recommendation:

We advise investors to review in corporate results in detail, basing decisions on fundamental analysis with a medium-long term outlook due to the fact that first quarter results will not fully reflect annual results. Furthermore, investors should consider seasonal effects, regional developments and the timeline related to development projects. Based on this, we advise investors to focus on companies that can adjust well to the current fiscal landscape and protect their profit margins. With a partial return of liquidity in addition to increasing first quarter results announcements, we expect market activity and depth to improve. Investors would be wise to avoid uncalculated speculative activities, which usually come at the expense of the small investors, leading them to exit the market. We also expect several companies with attractive valuations to witness positive momentum on their stock prices.
