MSM Performance:

Foreign institutional investors again made their presence felt in the market. That coupled with various news related to the infrastructure, construction and oil sectors, in addition to key international events, the MSM30 index, ended the week (September 9 - 13) gaining 0.51% on weekly basis to close at 5,589.47 points, despite of pressure on some key stocks.

Blue chip stocks especially the ones with solid fundamental factors were able to attract investor interest especially foreigners. The index was supported by companies like Omani Qatari Telecommunications Company (Nawras), Oman Cement, Renaissance Services and Galfar Engineering.

During last week, Al Arabi Oman 20 Index Increased by 1.23% to finish at 1013.77 points as turnover amounted to RO20.05mn. Al Arabi GCC 50 Index increased by 1.57% to close at 983.63 points. Also, "Al Arabi MENA200 Index" registered increased of 1.1% to close at 932.29 points.

In the analysis of sub-indices, the industry sector still offers the best performance achieving an YTD growth of 19.4%. The index ended the week gaining 1.92% on a weekly basis to close at level of 7,114.8 points getting support from several stocks such as Oman Cement Company, Galfar Engineering and Contracting, Al Anwar Ceramic Tiles and Al Hassan Engineering Company.

Al Hassan Engineering announced that it had been awarded by Petroleum Development Oman LLC (PDO) a contract of USD 106.3mn for engineering, procurement, construction and commissioning for Zauliyah Gas Plant, through its joint venture with Tecnicas Reunidas S.A (the share of Al Hassan Engineering in the JV is 70%). This news supported the noticeable movement of Al Hassan's shares which has continued over the past couple of weeks.

The share price soared by 10.2% on weekly basis to finish at RO 0.184 per share. It is worth noting that according to our data base, the total projects assigned to the company since the beginning of the year amount to RO 77.3mn

In further evidence of the activity witnessed by the construction companies, Galfar Engineering and Contracting continued to obtain tenders, the latest being the Mukhaizna Airfield upgrade for Occidental Mukhaizna LLC, with a contract value of RO 6.9mn, raising the total amount of tenders from the beginning of the third quarter to around RO 40mn.

Galfar which witnessed significant trading activity during the week was the top traded stock in terms of value, closed the week at its highest level in more than 4 months at RO 0.424 per share, gaining 11.6% on weekly basis.

With Oman transport infrastructure summit taking place during the previous week, the infrastructure sector was in focus, especially the roads segment.

It was announced that the investments for building various road projects in Oman, which is currently are valued at RO 1.5bn for the running projects, is expected to go up to around RO 3bn by the end of 2013.

Among these, the vital one is the Al Batinah Expressway project (length 365 km) where two of the project packages have already been awarded, with the first one commencing construction and the 3rd package is expected to be awarded soon. Also there is the key project of the dualisation project by Bidbid / Sur length of 250 km

In view of this, infrastructure, construction and related companies especially local ones are expected to benefit from the government's commitment towards fiscal spending, the thing that already started.

Remain locally, the Tender Board, awarded RO 65mn worth of projects making total awarded tenders during this year around RO 1.1bn, i.e. 62% of the total awarded tenders in year 2011.

Back to sub-indices analysis, Services Index came second, up by 1.18% on a weekly basis to close at 2,701.29 points, supported by the shares of Renaissance Services and Oman Qatari Telecommunications Company (Nawras).

The financial index witnessed a weekly decline of 0.34% to close at 6,280.56 points pressurized by banking shares and some holding companies and investment.

Ominvest's shares witnessed selling pressures throughout the beginning of the week on the back of the announcement that the company has recorded a loss of RO 1.75mn on its investment in Digital Domain Media Group Inc. (listed in USA), after the sharp slide of the latter's shares recently.

It is worth noting that the company has stated that its income statement for the first half of this year included unrealized gains on the same investment. The company announced that the above disclosed loss has no material impact on its financial position. The stock ended the week losing 3.2% to close at RO 0.358 per share.

During the previous week the Capital Market Authority approved the "Al Ezz Islamic Bank" prospectus and identified 22nd of this month as the commencement date of subscription which will continue for a month and will be open to both Omani and non-Omani investors. The Bank will offer 400mn shares for public subscription at 102 Bz per share (100 Bz representing the par value with an addition of 2 Bz per share as expenses).

Also, Islamic banking in sultanate still awaiting the final legislation and the organized instructions as well as the amendments to the banking system. It is to be noted that these have been studied and discussed with the relevant authorities in the Shura Council and await to be approved by Royal Decree.

Analysis of investors trading activity shows that volumes and traded value increased (as we earlier expected) by 3.59% and 22.42% respectively to 110.6mn shares with value of RO 29.0mn on weekly basis. It is important to note that the average weekly turnover in the previous week stood at its highest in 3 months at RO 5.8mn


As we mentioned earlier, foreign institutions continued to be in the market with a notable net buying of RO 1.63mn absorbing the selling of local institutions and all GCC investors. It is worth noting that local individuals were also among net buyers which we encouraged earlier about benefiting the attractive opportunities in the market.

In a key international development, a German court cleared the way for Germany to participate in the European Stability Mechanism Fund (ESM). This news was welcomed by the global markets with market participants seeing this move as a measure to control against further downward spiral of the European crisis.



Recommendation:

We expect the continuity of the interest shown by institutions and investment funds in the Omani market in the coming days before the results season begin, bearing in mind the attractive ratios and healthy indicators enjoyed by local companies compared with their peers in different markets.

As we had predicted, building positions have already commenced especially in the companies that are related to the government tendering activities and which are benefited from any announcement in this regard.

We advise investors to watch closely and monitor the governments announcements especially which are related to tenders in addition to the government plans, programs and strategic view. Investors should analyze upcoming announcements with the assistance of their portfolio / investment managers with an overview of over than three months on the market thus to benefit from the market moves.

We still advice investors to start building positions now and avoid speculations especially on the companies that do not enjoy solid financial indicators.
